CHRONOLOGICAL HISTORY of YALOBUSHA COUNTY, Ms.

- I. Dec. 23, 1833- Created from MONROE, WASHINGTON and non - county area of HOLMES COUNTY. 900 sq. miles.
- II. June 6, 1852 - Lost 720 sq. miles to creation of CALHOUN COUNTY, which included SABOUGHHA, BIG CREEK, SHEPARD and BANNER villages or census prescient
- III. May 9, 1870 - Lost 460 sq miles to creation of GRENADA which included HARDY, RIVERDALE, YOUNGS, GORE SPRINGS, AND THE YALOBUSHA RIVER.
- IV. May 23 1873 - Gained 480 sq miles from Lafayette County which included the forks of the YOCONA and OTOUCATOFA RIVERS from the northern city limits (hiways 7 and 315) of Water Valley to the present Lafayette county line
